Grafton Road Culvert—update

As many residents will be aware, heavy sustained rainfall causes the Grafton Road culvert (Attenuation Pond) to overflow resulting in the pooling of water at the roundabout of Grafton Road/Violet Way/Beaufort Road junction. This is a relatively new phenomenon caused by the blockage of the system designed to store water in the attenuation pond and regulate the flow of water underneath Woods Lane and eventually out into the River Trent near Stapenhill Hollow. Although at first it appeared to be linked to the new Strata Homes Development, Severn Trent Water confirm that this problem has been there since 2016 so pre-dates any construction work carried out by Strata Homes.

Although Severn Trent attend to unblock the system, the deadwood and rubbish in the attenuation pond causes regular blockages. It has been found that the grills preventing debris entering the system are too wide and trees planted around the grilles should never have been given permission. Three actions have therefore been proposed to resolve this issue:

1. Replace the grills to prevent large debris entering the system which regulates water flow;

2. Remove the trees in the immediate vicinity (trees which should not have been planted in the first place)

3. Maintain and potentially replace the current flow regulation system which can be operated manually if required.

Strata Homes are working closely with Severn Trent Water and East Staffordshire Borough Council having obtained quotes for the fabrication and installation of the grills. Once these grills are fitted, Severn Trent will inspect the flow control device, and potentially replace it with something more suitable and maintain the appropriate device monthly. East Staffordshire Borough Council are to remove the trees in the vicinity and pay for the grills as mentioned. Partners believe that this combination of actions will bring this issue to a close.

Stapenhill Road Crossing

Conor Wileman, Staffordshire County Councillor for Brizlincote and Winshill has been working for several years to secure funding for a pedestrian crossing on Stapenhill Road after being made aware by residents in the area that the A444 acted as a deterrent from safely walking into Town or using the Washlands.

The Parish Council are now delighted to announce that work has started on the installation of this crossing. The pedestrian crossing will use traffic signals and will allow adequate visibility for both drivers and pedestrians.

The funding was secured off the back of s106 development contributions from the nearby Drakelow development and in addition to the funding for the crossing itself, further contributions of approximately £40,000 have been secured to fix the drainage system in the vicinity. Pooling water near Stapenhill Hollows has been a long term issue and one which will now be resolved as a result of this further funding.

Councillor Conor Wileman said, "I am absolutely delighted to have been able to secure funding for this much needed scheme and I would like to thank residents for bringing the safety of crossing the A444 to my attention some years ago. I am sure this crossing will mean that more residents will feel safe to walk into Burton Town Centre and it will increase the use of the Washlands. Promoting walking and using our green spaces will also undoubtedly have many other benefits too. It's a real bonus that the water pooling issues which have plagued Stapenhill Road will also be resolved and I have asked this work to take place as soon as possible and with minimal delay to road users."

Brizlincote Parish Council together with Borough Councillor, Bernard Peters have also helped shape the plans and pressed for action in this location.



Dog Fouling Campaign



We've launched our latest solution to tackle Dog Fouling!

'DO IT FOR YOUR DOG'

Our latest research into Dog F<mark>ouling</mark> found that 15% of dog owners admit to letting their dog poop in a public place without picking up, leading to 76% of adults stepping in dog poop in their lifetime.

This is why we<mark>'ve launched our latest c</mark>ampaign to tackle this noxious problem. The campaign features dogs as the messenger, appealing directly to dog lovers and leveraging the levers of both pride and shame to remind owners to pick-up their poop because it's what their dog would want them to do.

We want to see dog fouling substantially reduced by 2020 and all but eradicated by 2030. We will continue to develop and support campaigns or initiatives focusing on dog owners' reasonability and supporting the concept of 'any bin will do'.

We will support local authorities in incentivising citizen action, or implementing new rules under PSPOs requiring dog owners to carry a poo bags. And lobby for sufficient finance to support Local Authorities in effective investigation and enforcement.

We will con<mark>tinue to</mark> oppose interventions that require mass sampling or DNA collection from dogs, unless supported by government legislation and finance for both delivery and enforcement.

Operation Icy is currently ongoing with regard to theft of tools from vans and catalytic converter thefts.

Operation Automatic is targeting County lines activity to protect, pursue, disrupt and prevent further criminality and to safeguard the vulnerable.

East Staffordshire as a whole is being hit by these offenders. Theft of tools and catalytic converters is hitting Staffordshire including Winshill and Stapenhill, please report any suspicious activity.

Please continue to be aware of ongoing scams and bogus officials, either by phone or people knocking at your address, calls claiming to be from HMRC, electricity, water, gas board etc. Please be alert to these bogus officials. Do not buy or sell to callers at the door or over the phone. Check elderly/vulnerable neighbours and relatives. Never engage in conversation from random unexpected callers. Genuine companies won't mind you checking their details and calling the company for clarification. Do not give out any personal information and never give your bank details over the phone.

The police say someone had their bank accounts emptied after they paid a taxi driver with a debit card. They had wanted to pay with their credit card, but the taxi asked for another method because he didn't want to pay the 4% visa fee. Police advise that whenever you are asked to use a debit card instead of credit card for whatever reason, enter the wrong PIN. If it is a counterfeit machine it will pretend to process the payment and produce a receipt. Whereas an authentic machine will reject the PIN and request a "try again" message. Help spread the word, as the police state this type of fraud is becoming increasingly prevalent.

Theft continues of keyless vehicles. Ensure that keys are kept in a tin for safety.
