Feedback from Councillors, judges and participants included ideas such as a category for young peoples' gardens, changing the time of the year of judging to allow for gardens which are at their best in spring or autumn, and the introduction of categories such as allotments and/or vegetable gardens. A suggestion was to differentiate between small and large gardens within the categories. Another suggestion was made regarding the potential for the public to nominate gardens they think worthy of an award.

The entrants requested feedback on all gardens judged to see where it was felt that their gardens could be improved; this led to an idea of a comment slip given to each garden by the judges.




Rev Michael Mookeji to retire in 2015

Am I Qualified to be a Parish Councillor?

Most people are. However there are a few rules. You have to be:

A British subject, or a citizen of the Commonwealth or the EU; and on the "relevant date" (day on which you are nominated or if there is a poll the day of the election) 18 years of age or over;

You must have lived in the parish or within 3 miles of it for the whole of the 12 months preceding the "relevant day".

You cannot stand for election if you are the subject of a bankruptcy restriction order or interim order, or have, within five years before the day of the election, been convicted in the UK of any offence and have had a sentence of imprisonment (whether suspended or not) for a period of over three months without the option of a fine.



Election Day May 7th 2015

You may have already heard enough about the 7th May and the General Election. Please do not to forget the local elections are also on that day, this includes electing the Brizlincote Parish Council.

There are 11 seats to fill, please consider offering your services. The meetings are on the third Thursday of each month at 7 pm in the Violet Way Academy.

On Thursday 14th May the Annual Parish Meeting will be held also in Violet Way Academy at 7 pm.

You are always welcome to attend these meetings, and if you do decide to stand, as I hope a good number will, contact the Parish Clerk with a photograph along with a note about yourself and your aspirations (not more than 50 words) by the end of February for publication in the next newsletter.

Road Traffic Regulation Act 1984 (As Amended), Road Traffic (Temporary Restrictions) Act 1991

MALVERN STREET AND MALVERN AVENUE, BURTON UPON TRENT DIVERSION OF VEHICULAR TRAFFIC

NOTICE is hereby given that the Staffordshire County Council intend, not less than seven days from the date of this Notice, to make an Order the effect of which will be to prohibit any vehicle from proceeding in that length of Malvern Street and Malvern Avenue, Burton upon Trent from its junction with Spring Terrace Road for a distance of approximately 350 meters in an easterly direction unless the vehicle is being used in connection with the works. Vehicular access to frontages will be limited. Pedestrian access will be maintained. The alternative route for traffic will be available via Spring Terrace Road, Woods Lane, Spring Farm Road and Clay Street.

The order will come into operation on 05 January 2015 at 09:00, and the said works will commence on or as near as practicable to that date. The works should be completed by 31 January 2015.

The Order will remain in force for a period of 18 months or until the gas mains renewal and connection works, which it is proposed to carry out on or near the road, have been completed, whichever is the earlier.
