# 84/08 APPROVAL OF THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON 18 OCTOBER 2008 -

### 85/08 MATTER ARISING FROM MINUTES -

Councilor Willett raised item 70/08 - Bulb Planting. Bulbs were planted by Chapman's Nurseries with help from the Children. Burton Mail attended and picture was in the paper. Councillor Willett thanked the mail for attending.

Councillor Williams asked if the clerk could write to Chapman's Nurseries to say a big thank you for their kind help.

Councillor Willett raised 78/08 - Charity - Burton East Sport Trust. Councillor Willett and Warrilow attended the meeting at the end of October.

Councillor Muir updated members of the meetings. He was pleased with the turnout of people. Due to meet again on 27 November and will have an extended version of the deeds. Will be able to apply for Seed funding once established the trustees (6 or 7). Already has an offer of a mini-bus to use. To have a public meeting twice a year and a meeting with Trustees at least 4 times a year. Members to elect trustees. Currently has over 30 member's club.

Councillor Warrilow asked if they had received any other correspondence from other Parish Councils. Further discussion took place.

Councillor Williams to attend the next meeting on the 27<sup>th</sup> November at Bridge Brewery.

Councillor Willett raise 81/08 - Gangs - They are coming early January to the Brizlincote area. The will include grounds maintenance such as cutting back hedges, pot holes, broken barriers/railings etc. Will be writing to the Clerk early December to ask for areas that need attention.

Councillor Williams asked members to have a look of at the street/area where they

live and report any works to him that you think need attention.

Clerk to ask SPCA about how to elect a new member. Burton Mail to put in the paper to inform residents that that the Parish have a vacancy.

Councillor Peters thanked members for changing the date of the meeting as from December.

Discussion took place early with regards to the Vodafone Phone Mast. Councillor Peters informed members that he has spoken with the Planning Department and because this is less than 15 meters then it would be delegated powers.

Councillor Alam does not wish for this mast to be erected for the problem of visibility and health reasons. This is not a suitable location for this. Councillor Alam to write to Peter Short at ESBC to express concerns.

Letter from Vodafone was received but the consultation period had expired. Chairman to write to Vodafone to express concern.

Councillor Willett suggested we contact Diane Needham, Youth Worker who mentioned a new Cabin on Paulet School grounds to help form a new youth centre. Councillor Williams to raise at the meeting on 27<sup>th</sup> November as she will be present.

# 89/08 COUNTY & BOROUGH COUNCILLORS REPORT -

County Councillor Muir update -

Fire Service had a target of 2800 activities they would work on this year, report stated that this has fallen to 2300 which is good as accidents have reduced.

Police in April 2000, had just under 22,000 police officers now there are 24,300, an increase of 2,300. Crime down by 12%. County contributed £3 million, which would create a further 38 Police Community Support Officers 16 Community Workers.

Waste - £122.4 million towards an energy project within South Staffs Counties. They would take in waste from neighboring authorities i.e. west midlands.

Performance, there are 388 councils in the land and Staffordshire County Council is ranked 4<sup>th</sup>.

Borough Councillor Insley informed members Footpath between The Maltings and Ashbrook needed barriers (an issue already raised with Staffordshire County Council)

Councillor Willett & Warrilow attended the recent Police meeting. Noise issue around Tesco Express area, amount of youths still congregating around the shops. Malvern St/Clay St - youths congregating in ally. Owner next to this walkway wants to place a gate with a lock to prevent this from happening.

Councillor Willett raised the new development near Brizlincote Lane and Ashby Road. New retaining wall which is in yellow bricks. Out of keeping with the area.

Clerk to write to the planning to express concern about the colour of bricks.
