10/091 Robert Everiss of ESBC and Di Needham of Staffordshire Young Peoples

Services– addressed the meeting regarding Open Spaces and Youth Provision development within the area.

Mr Everiss gave out details of proposed works being considered for the open spaces within the Parish along with maps showing the sites clearly. It was agreed that the Council would look at any unspent precept provision towards the end of this financial year to see of the Parish Council could assist with any of the proposed refurbishment work. This will be considered by a committee set up for this purpose.
