PUBLIC SESSION

The meeting was opened to the public to raise any issues for the Council to consider:

A member of the public asked about the rights to trim a hedge owned by the local Council. This location has been included as part of the full survey and will be taken forward as part of this project.

A member of the public asked about the current situation regarding the potential play area on Beaufort green. An update was given and this led to discussion regarding provision for 13- 19 year olds in the area.

A member of the public asked if there had been any further development on the Model Farm proposals. The Chair responded that no further documentation regarding any planning application had been received.

10/033 Apologies

Apologies were received and accepted from Kathy Lamb, Bernard Peters and Kay Sherratt.

10/034 Declarations of Interest

Members did not declare any interests in any matter identified for discussion at the Meeting.

10/035 Minutes of the previous Council Meeting

The Minutes of the June Parish Council Meeting, held on 17th June 2010 were approved with an amendment to the title for item 10/025. Clerk to action

10/036 Newsletter

The Council received the Committee's report on the printing and distribution of the newsletter. It was suggested that delivery options should be considered again before the next edition goes out. The Clerk was asked to put this matter onto the Agenda in September. **Clerk to action**

10/037 Grant Application from North Stapenhill Allotment Association

The Council considered whether to grant funds for the application from North Stapenhill Allotment Association for a grant of £470.00. The Clerk gave details regarding an issue with livestock on the site as requested by Councillor Peters. It was decided that this matter was a separate issue and should not form part of the grant discussions. The Chair proposed that the grant be given. This was seconded by Councillor Muir. A vote was taken with no members in favour and 7 against with 2 abstentions. Therefore this proposal was not carried. The Clerk was asked to communicate this to the association.

10/038 Burton in Bloom Competition

Councillor Lomas gave an update on the entrants and the judging details. The Competition will be judged on Saturday July 24th – time to be agreed. The Clerk will communicate with all the entrants to let them know the date and time once this has been agreed. One entrant falls outside the parish and details were given of the Winshill competition. The Clerk will contact this entrant to pass these details on. Further details about the Burton in Bloom judging were also given.

10/039 Feedback on Tree and Hedge Surveys

Councillor Lomas suggested the use of a proforma for future surveys as collation was time consuming. A meeting has been requested with ESBC and it was hoped that this would take place shortly after the Parish Council Meeting.

'This application is obviously an afterthought following the problems caused by the creation of a single access for four properties off Ashby Road.

The block plan is incorrect as it does not show the property which is under construction on the corner of Ashby Road and Brizlincote Lane.

The access has already been constructed and, in my opinion, will enable the occupant to enter and exit the property more safely than the access on Ashby Road.

The existing hedge has been removed and replaced by a close boarded fence which is detrimental to the area and the hedge should be reinstated.'
