Minutes of Brizlincote Parish Council meeting held at Violet Lane Infant School on Thursday 20th May 2010

The Clerk opened the meeting by welcoming all and explaining that the meeting would start with the AGM and the election of the following posts:

Annual General Meeting

1. Election of Chairman

Councillor Sherratt nominated Councillor Willett, Councillor Lomas seconded this and all were in agreement. Councillor Willett accepted the position.

2. Election of Vice Chairman

Councillor Goldstraw nominated Councillor Warrilow, seconded by Councillor Ball with all in agreement. Councillor Warrilow accepted the position.

3. Election of other posts/responsibilities as appropriate

It was suggested that all other positions and committees remain as they were. This was accepted unanimously.

PUBLIC SESSION

Speakers from District Council regarding Green Spaces and Beaufort Road Project

The speakers gave details of a suggested development on the Beaufort Road Green Space for 8-13 year olds. There was much discussion from Councillors and members of the public around issues of safety, anti-social behaviour and other sites that could be identified. It was agreed that copies of the original Playbuilder bid for the project would be passed to the relevant committee who would report back to the next Parish Council meeting. Many thanks were extended to the representatives for their time.

To be put onto the next Agenda

The meeting was then opened to the public to raise any issues for the Council to consider:

Members of the public discussed a planning application for 18a St Peter's Street. There were several residents who will be affected by this development. A site visit has already taken place but the residents felt dissatisfied with the outcome of this meeting. Residents also pointed out several perceived errors in the planning application.

A member of the public commented on grave concerns about the play area development from his previous experience of living close to a similar site in the past.

10/001 Apologies

Apologies were received and accepted from Ruth Goldstraw, Jim Muir and Bernard Peters.

10/002 Declarations of Interest

Members did not declare any interests in any matter identified for discussion at the Meeting.

10/003 Minutes of the previous Council Meeting

The Minutes of the April Parish Council Meeting, held on 15th April 2010 were approved.

10/004 Neighbourhood Forum Action Plan review

The Councillors' report on the review was read and accepted.

10/005 Verbal report regarding meeting with North Stapenhill Allotments Association

The meeting receive a verbal report from Councillor Willett regarding this meeting which took place on 13th May 2010. The newly planted bank needs attention and the gate has sagged. These matters will be reported through Clarence by Councillor Willett. It was agreed that Councillor Willett would discuss the matter of the grant for a heavy duty strimmer with the Association again.

The meeting received a report from Councillor Lomas on this matter.

10/007 Tree and Hedge Protection

The Council considered an email received regarding Gloucester Way and decided to do a survey of all trees and hedges in the Parish to identify work needed and any potential preservation orders needed. The Clerk was asked to allocate areas to each Councillor to cover and identify any areas that they feel need attention. This is to be done as soon as possible so that a report can be given at the next meeting. The Clerk was asked to put the matter on the next agenda.

It was agreed that problems of anti social behaviour in Redwood Drive and parking problems outside Violet Lane School should be investigated. Further to this, it was commented that there have been no reported incidents involving an injury within the Brizlincote Valley since October 2008.

The Council discussed the pledge from the local MP and decided to ask for more 30 mph road markings within the parish. It was noted that Speedwatch should be active within the next week.
