### 10/081 Declarations of Interest

Members did not declare any interests in any matter identified for discussion at the Meeting.

### 10/082 Minutes of the previous Council Meeting (21<sup>st</sup> October 2010)

The Council approved the Minutes of the August Parish Council Meeting, held on 21<sup>st</sup> October 2010, as a correct record after the amendment of a Councillor's name entered twice.

### 10/083 Financial Regulations and Risk Assessment

After an amendment to section 6 removing reference to the 'Clerk and RFO', Councillor Willett proposed they be approved and passed as policies. This was seconded and a vote was taken with all in favour excepting one abstention.

## 10/084 Protocol for dealing with overgrown boundary hedges, bushes and trees that obstruct public footpaths

Councillor Lomas to gave background information and discuss the issues around this matter. He then moved the motion that:

# The Brizlincote Parish Council should regularly check pavements and footpaths and report to the appropriate Authority any obstructions caused by overgrown boundary hedges, bushes or trees.

It was agreed to note that the check should take place twice a year with May and late July suggested as appropriate times to do this.

Councillor Arthur Goldstraw seconded this motion and all were in favour.

It was agreed that the responsibility to contact the owner of the identified boundary should rest with ESBC or Staffordshire Highways, and not Brizlincote Parish Council.

### 10/085 Planting Update

The update given to all Councillors at the end of last meeting was reviewed. There was a discussion regarding the upkeep of an area opposite Hargate Road. The Clerk was asked to write to the developers – William Davis of Loughborough to ascertain the owners of this plot.

It was agreed that the work suggested by the report at the sites identified, should be undertaken especially if ESBC would contract on behalf of the Parish Council. With reference to the standing orders, it was agreed that a second quotation should be sought and then the Clerk was asked to move on this matter once this had been received.

### 10/090 Clerk's and Members reports

The Clerk reported regarding an email from Robert Everiss of ESBC and that he and Matthew Mardling would be attending the next Parish Council meeting to speak about open spaces within the Parish.

Councillor Webster's report was read by the Clerk regarding potholes on Lyndham Avenue.

Councillor Warrilow reported on Speedwatch, giving details of the number of vehicles exceeding the limit.

Councillor Lomas reported regarding the delivery of newsletters. It was noted that several roads appeared to have been missed for delivery and the Clerk was asked to write to Handover leaflets to express the disappointment of the Council with a list of roads that had been missed. It was agreed that this matter be put onto the next agenda to discuss possible alternative methods of delivery.

Councillor Ball queried the arrival of the agenda for the notice boards. The Clerk noted that the agenda had not arrived with all Councillors this month and most had only received it on Tuesday of the week of the meeting. She informed all Councillors that the agenda is set 7 days before the meeting and is usually available via the website very shortly after it is set.

Councillor Bidder reported on the workmanship of the railings erected by Carpenter Close. He gave details that Councillor peters is looking into the matter.

Councillor Willett reported on the Neighbourhood Forum meeting noting a suggestion that a pedestrian crossing within the parish had been suggested at the junction of Grafton Road, Woods Lane and Violet Way. He also reported on the site meeting that had taken place regarding Malvern Street parking issues. Whilst making the route one way was unlikely due to the fact that this would increase the speed of traffic travelling along the road, there will be further consultation and fuller feedback will be given in due course.

Councillor Willett also discussed the history of footpaths within the Parish and noted that he would like Councillor Peters to pursue this information.

The Chair thanked all present and the meeting closed at 8.30pm. The next meeting will take place on 16<sup>th</sup> December 2010.
