Minutes of Brizlincote Parish Council meeting held at Violet Way Academy and Nursery on Thursday 19<sup>th</sup> September 2013

## 49/13 Public Participation

The Police representative was welcomed to the meeting and she reported to the group first as she had an incident to attend. PCSO reported on thefts from vehicles in the area and on the issues on-going at Tower Woods including the recent fire at the play area. There were questions taken regarding covert operations around vehicles, progress regarding the vandalism at Tower Woods and a query regarding the removal of a den built in the woods.

The Chair welcomed all to the meeting and then made the presentations of certificates, prizes and trophies from the Brizlincote in Bloom competition held earlier in the year. The Judges and Competitors were thanked for all their efforts as were the Councillors who helped to organise, publicise and oversee the event. The Council were glad to see more entries this year and hoped for the continuation of this growth of the competition over the coming years. Photographs were taken for the newsletter.

Borough Councillor Jake Fellows' report was read to the meeting by the Clerk. This included an update on the work at Quorn Close, the issues at Tower Woods and other issues that have arisen.

Councillor Willett noted flooding problems outside 57 Spring Terrace Road and in Woods Lane by the Co-op carpark.

County Councillor Conor Wileman reported with an update on parking at Violet Way, the consultation over Spring Terrace Road and taking a wider view on the infrastructure of the whole area. He also reported on the shrubs on Stanton Road, the up-coming Fire Authority Strike and the increased need for vigilance and the works on Quorn Close moving on to Cottesmore Close in due course. A member of the public asked about the turning area on Cottesmore Close and there were other questions on Violet Way parking and the overgrown hedge outside nos 2-4 Clifton Way which Councillor Wileman offered to follow up if the reference number for the original report could be forwarded to him. The Chair asked if consultation regarding rail provision should be with SCC and this led to a discussion on passenger trains. This led back to the strategic planning required as a result of projects such as the impact of development at Drakelow and Councillor Wileman spoke about the overarching impacts and infrastructure planning required.

Councillor Peters spoke about the Neighbourhood Priorities forum as noted on the Agenda with respect to the work at Tower Woods suggesting that the Parish Council may wish to lend their support to an ESBC priority of CCTV at the site. The Chair also raised the matter of strengthening the neighbouring track to Elms Road and it was agreed to discuss this further later in the Agenda. There was also a discussion regarding parish signage – progress is to be checked by the Clerk.

There was also a query from Councillor Wileman regarding the placement of the site.

Feedback regarding Grit bins had been received from SCC. The Clerk was asked to clarify how far the present bin could be moved towards Jasmine Close and Councillor Wileman offered to look in the gritting routes and site of bins with the officers concerned.
